5. Provide necessary space, furniture and grounds for the school.

8. Accounts should be periodically reviewed and submitted to this office.
9. Fixed Deposit must be renewed from time to time.
10. Must follow and teach the state curriculum as prescribed by department.
11. All accreditation rules in the Karnataka Education Act shall be followed. If any of the conditions violated, the Validity of the recognition will be revoked.
12. Corporal punishment and mental abuse of school children is strictly Prohibited.
13. 25% of the seats must be reserved as per The Right to Free and Compulsory Education Act, Section 12 (1) C (excluding minority unaided schools) and infrastructure must be maintained as per Notification of Government No: ED: 27 Information 2012 dated: 8-05-2012 all other rules and regulations must be complied with under this Act.
14. All measures provided by the Commissioner of Safety, Circular No: C7 (2) CMA / SHMC40 / 2014-15, dated: 23-07-2014 Must be strictly implemented. Otherwise, this order is subject to cancellation.
15. All condition with respect to language policy must be followed as per the Government Notification ED 240 PGC 2017 Date: 10-05-2017 and ED 274 PGC 2017 Date: 21-10-2017 and Kannada language must be compulsorily taught from 1st to 10th standard as first or second language.
